When surfaces are to be prepared for painting, account should be taken of the age of the property and the possibility that lead-pigmented paint might be present. There is a possibility that ingestion or inhalation of scrapings or dust arising from the preparation work could cause health effects. As a working rule you should assume that this will be the case if the age of the property is pre 1960.

Where possible wet sanding or chemical stripping methods should be used with surfaces of this type to avoid the creation of dust. Similar precautions to those given above about sanding should be taken with reference to protective clothing, disposal of scrapings and dusts, and exclusion of other personnel and especially children from the building during actual work and the subsequent clean up operations.

Avoid the inhalation of dust. Wear suitable face mask if dry sanding. Special precautions should be taken during surface preparation of pre-1960s paint surfaces over wood and metal as they may contain harmful lead.
